TUITION INFORMATION

Registration Fee.

This is a non-refundable fee, which is deducted from your tuition. It is due one week after acceptance for new families and February 12, 2009, for returning families.

Payment Options.

The tuition balance remaining (after the registration fee is applied) can be paid in one of three plans:

- Monthly Plan – 10 equal payments starting August 1, 2009, last payment in May 1, 2010.
- Semi-annual Plan – Two payments, due on August 1, 2009 and January 1, 2010.
- Annual Plan – One payment in full, due August 1, 2009.

True Cost of Education.

The true cost of educating a child at St. Martin's is more than \$7,500.00. In an effort to make a quality Catholic education as affordable as possible, while also striving to be a model employer, St. Martin's Parish contributes a significant amount from the weekly offertory of all parishioners for the operations of the school. This parish support makes up part of the difference between the true cost of education and the amount of tuition collected. The remainder comes from fund-raisers. Many parents work countless hours each year to ensure the success of fund-raisers. Your help is needed. All Catholic families grow in their faith and help strengthen the parish family by being active and involved members of the St. Martin's community.

Family-Friendly Discounts.

Families with multiple children attending St. Martin's receive a tuition discount for multiple children. The tuition of the second child is **85%** of the tuition of the first child. Likewise, the tuition of the third child is **70%** of the first child. The tuition rates for the fourth and fifth children of a family attending the school are **50%** of the first child's tuition.

FEE SCHEDULE

The academic resources fee for 2009-2010 is \$400. This fee provides funds to partially defray the costs of textbooks, technology, classroom supplies, special class events, some HSA activities, and other operational needs. The fee is charged on a per student basis. Due date: July 1, 2009.

The lunchroom fee for 2009-2010 is \$45. This fee provides funds to partially defray the costs of coordinating the parent network for daily lunchroom and playground volunteers. This fee is charged on a per family basis. Due date: July 1, 2009.
